You must bring your own heavy-duty extension cords and they must be a minimum of 100 feet. You may not pull over 20 amps of power.

This Event will be held rain or shine. Refunds will be issued only if we must cancel due to Covid 19 restrictions. Admission is free to the public. Parking is free at Coral Shores High School. Some on-site vendor parking.

Vendor may not sell, distribute, or display any items associated with elected officials or candidates for public office, their campaigns, slogans, or any other materials deemed by church, in its sole discretion, to be political in nature or inappropriate for Event. In addition, Vendor may not sell any food or beverage items intended for consumption at Event.

Church reserves the right to evict Vendor from Event grounds if any of the provisions of this agreement are not met, or for any other reason or situation believed by Church, in its sole discretion, necessary to maintain a wholesome family environment. Church also reserves the right to require Vendor to remove any items Church finds objectionable. No refund will be made as a result of any eviction or item removal.

Release Agreement

In consideration of the sum set forth above and the mutual obligations of the above parties involved in the Coral Isles Church Winter Festival (hereinafter “the Event”), I, the undersigned, on behalf of myself and any corporate entity which I represent for its participation in the Event, if any, and on behalf of all of my and/or the corporation’s employees, agents and volunteers who are participating in the Event, or are otherwise present for the Event, with the intention of binding myself and all others listed above, hereby release, indemnify, discharge, defend and save and hold harmless the Coral Isles Church, all other Event sponsors and their agents, respective officers, directors and employees from any liability, claims, losses, demands, actions, fines, expenses, costs, judgments, all foreseeable and unforeseeable damages whatsoever, whether for personal injury (including death) or property damage arising during the Event or as a result of or due to participation in the Event. The undersigned, being fully aware of the risks and hazards inherent in participating in the Event, hereby voluntarily elects to engage in such activity and assumes all risk of loss, damage or injury to person or damage to property, while engaged in such activity. This release shall be binding on the distributees, next of kin, heirs, personal representative, and administrators of the undersigned or those of any individual who the undersigned is signing on behalf.

The undersigned irrevocable grants to sponsors the right to use his/her likeness, identifying logo or trademark in photographs, film or video for promotional use in any and all media.

Upon the undersigned vacating the assigned space, the undersigned agrees to leave said space in exactly the same state of cleanliness as when the undersigned initially occupied the space.

By signing this release, the undersigned hereby acknowledges and represents that he/she is of sound mind, has read this release, understands it and signs it voluntarily. Additionally, if he/she is signing on behalf of a corporation or any other entity, the undersigned represents that he/she has authorization to sign on behalf of such entity.
